5. GUIDING PRINCIPLES

The applicant understands that .za DNA is required in terms of section 34 to provide ADR financial assistance exclusively to fund complainants and registrants seeking financial assistance. The application procedure and eligibility criteria are used to assist .za DNA to determine whether or not financial assistance should be allocated. In considering each application, .za DNA is guided by the following underlying principles:

- (a) *Restriction to SA citizens*: financial assistance is limited to South African citizens.
- (b) *Affordability*: the applicant must prove that they cannot afford to pay ADR fees. .za DNA shall use “good cause” to determine ability or inability to afford ADR fees.
- (c) *Proof of abusive/offensive registration*: the applicant must prove that the dispute is based on abusive or offensive registration.
- (d) *Limitation to co.za domain*: financial assistance shall only be granted for co.za domain name disputes.

- (e) *Consideration by a single adjudicator:* the applicant who receives financial assistance shall choose a single adjudicator panel, unless the other party insists on a three (3) member adjudicator panel.
- (f) *Limitation for appeals:* assistance for appeals shall be limited to 50% of the total appeal costs to ensure availability of financial assistance to as many applicants as possible.
- (g) *Documentary evidence:* decisions to allocate or not to allocate financial assistance shall be made based on documents submitted by the applicant. No in-person hearings shall be conducted.
- (h) *Public interest:* .za DNA shall consider public interest in making its decisions.
