7. Comments (Optional)

The Adjudicator notes that, according to the WHOIS records of 3 September 2019, Kule Kidemba of Bougainvilla Place, 4 Rothert Street, Sonheuwel Central, Nelspruit, Mpumalanga was initially recorded as the Registrant of the domain name. Such details were however, on further review of the WHOIS records on 9 September 2019, redacted. The Adjudicator in this matter, on an independent review of such records, again confirmed that these details remain redacted. The Adjudicator further notes the questionable timing of such redaction of specific details from the WHOIS records, and, considering the correspondence between the Complainant and Kule Kidemba preceding such redaction, took such circumstances into account in ultimately coming to a decision in this dispute.

8. Decision

For all the foregoing reasons, in accordance with Regulation 9(1)(a), the Adjudicator orders that the domain name, *airportsa.co.za* be transferred to the Complainant.
