The Adjudicator further notes that IBD Compliance Services was initially recorded as the Registrant of the domain name, but transferred the domain name to current Registrant, Ursula Joubert, on receipt of a letter of demand from the Complainant. The Adjudicator is also satisfied that all reasonable steps to notify IBD Compliance Services of the dispute have been taken.

#### 8. Decision

For all the foregoing reasons, in accordance with Regulation 9(1)(a), the Adjudicator orders that the domain name, *uj.co.za*, be transferred to the Complainant.
